## Austin Bridge & Road LP

**Location:** Phoenix, AZ USA

**Industry:** Construction

**Product:** KLEEN KOTE



### Background:

Beginning in the early 1900's, Austin Bridge & Road LP is the oldest and most well-known contractor providing heavy highway services throughout Arizona, Louisiana, Oklahoma, Mississippi and Texas. As part of their services, Austin Bridge & Road provides precast and form liner concrete structures for public, private and civil sectors that include airports, highways, railways, and various inter-modal facilities. Austin Bridge & Road uses KLEEN KOTE on their Fitzgerald form liners as a release agent when pouring large projects such as the sound barrier wall along I-10 in Arizona, ½ mile from the city of Marana.

### Use:

Austin Bridge & Road would pour a 70,000 square foot sound wall with various detail and finish, creating an aesthetically pleasing finished project rising 24 feet and spanning nearly 3,000 feet along I-10. In order to create three varying details and finishes that would need to be perfect upon removal of the Fitzgerald form liners, KLEEN KOTE was applied to each form liner prior to use. After pouring the concrete, the form liners were removed with ease and a wall of perfection was complete.

### Results:

- **Perfect Detail over 70,000 square feet** – the only release agent of its kind to create a finished surface without imperfections when sprayed directly onto Fitzgerald form liners
- **Environmentally and User Friendly** – Biodegradable (no silicones, solvents or phosphates), V.O.C. compliant and water-based
- **Economical & Easy to Use** – Shipped in concentrated form to mix on-site as needed and sprayed directly on the forms prior to use
- **Durable Protectant** – Able to withstand the entire project, whether halted by weather; will not rinse off in rain

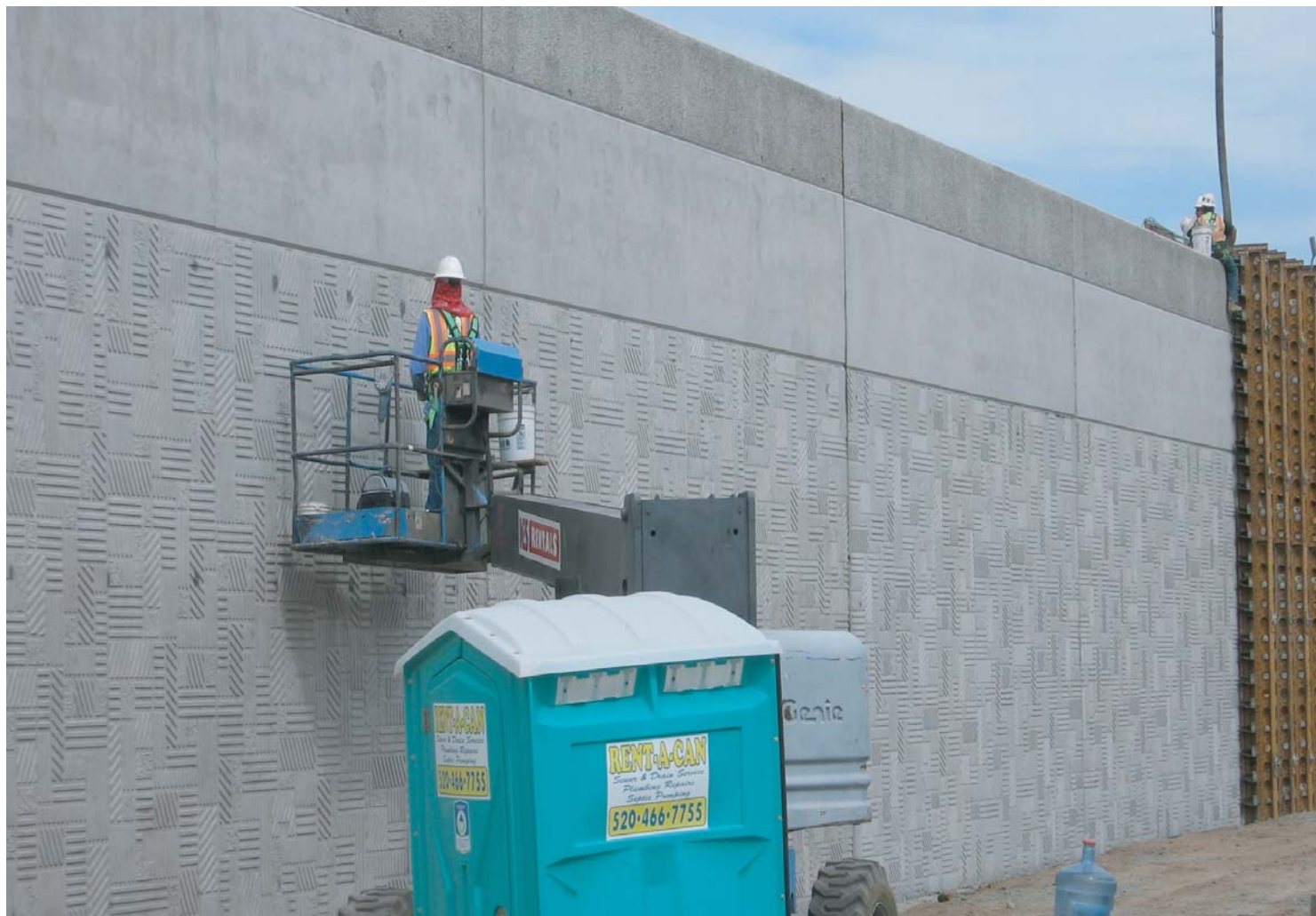
